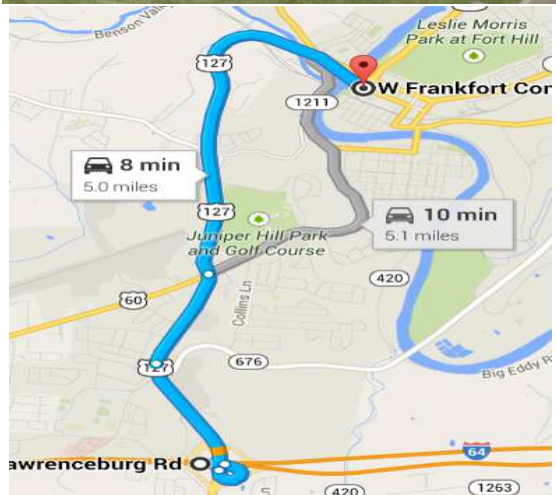
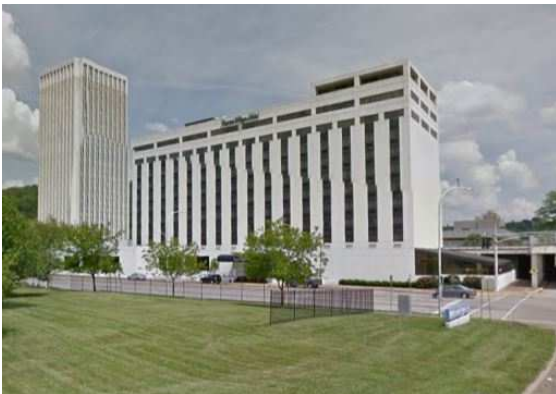

Take I-64 Exit 53B Northbound on Highway 127 / Lawrenceburg Road.
Travel 5.0 miles.

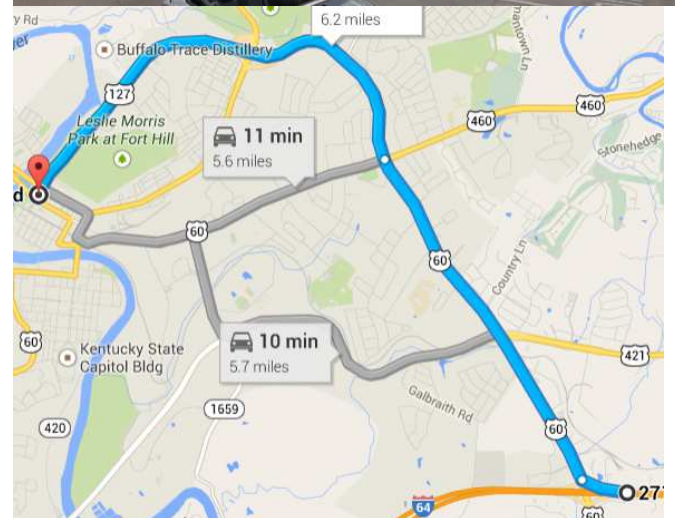
The Capital Plaza Hotel will be on the left, as soon as you cross the river.
